All events & leagues were cancelled this season due to Covid-19 restrictions.

Without any income from sponsorship or leagues a loss of £1k was incurred.

Fortunately all entrants in the Touch League have agreed to roll over their entry fees to 2021 with £1,875 being held in the balance sheet as deferred income

Also £4k of sponsorship received last season has been rolled over to the 2020/21 season.

The early payment of the 2020/21 membership fees was appreciated & we even had £850 paid before 1st October

The 2020 Euros were postponed with the provisional dates for the rescheduled event being from 3rd to 8th August 2021. Fortunately we were able to recover the FlyBe £2k flight deposits from a credit card company. A Euros debtor balance of £5.4k is shown in the balance sheet, £2.6k of this relates to accommodation deposit payments to Nottingham University which is due to be repaid shortly. The remaining balance relates to Entry fees for 2 teams which are being carried over to the rescheduled tournament
